I accept full responsibility for the safety, conduct, and supervision of any persons entering or using the property under my authority, supervision, invitation, or accompaniment, including but not limited to guests, passengers, dependents, contractors, invitees, and minors, and I undertake to ensure that such persons comply with all applicable rules and requirements at all times.
7. I hereby indemnify and hold harmless Marindafontein, its directors, agents, employees, representatives, and any person authorised to act on its behalf against any claims of any nature whatsoever by third parties arising from my conduct or from the conduct of any persons entering or using the property under my authority, supervision, invitation, or accompaniment, including claims arising from damage, loss, injury, or harm suffered by me and/or such persons.
